- 3. Discuss the \$38K budgeted in the Community Activities account category.
 - a. Specify the number of Mayor Delegation and non-Mayor Delegations planned for the remainder of FY2015 considering \$250 has been expended year to date, yet ~\$24K budgeted in FY2015.
 - b. Specify the benefit of the \$10K budgeted for WRC (Wilmington Renaissance Corporation).
- 4. Discuss the planned use of the \$18.5K budgeted for Advertising and Printing.
 - a. Justify how these funds actively market the City of Wilmington.
- 5. Discuss the ~\$10K budgeted between the Travel and Membership/Registration account lines.
- 6. Provide an update on the available fund balance in the Economic Development Strategic Fund.
 - a. Specify amount of funds since inception.
 - b. Specify the last time a cash infusion occurred.
 - c. Specify total amount of funds available, amount in pipeline for pending projects, amount available that has not been allocated.
 - d. Specify for the projects in the pipeline, the anticipated number of new jobs if any to the City, as well as any anticipated additional revenues to the City as a result of any incentives projected.
 - e. Specify number of new jobs as a result of these incentives per year for last 3 years.
 - f. Specify revenues generated and collected directly associated with the efforts of Office of Economic Development the last 3 years.

 - a. List the number of recipients who has been allocated funds by entity name, amount, and year.
 - b. Specify any projects in the pipeline.
 - c. Specify the total amount of funds allocated since inception for this fund.
 - i. Indicate the last time funds have been allocated and the amount.
- 8. Discuss the Wilmington Neighborhood Conservancy Land Bank and any potential funding from outside sources, considering Council recently passed an ordinance authorizing funding to the Housing Strategic Fund.
 - a. Specify your department's role within the Land Bank process.
- 9. Since the City's Economic Development Plan has been released publicly, specify how your department's budget priorities link to the overall plan.
- 10. Provide an update on any pending capital projects that Office Economic Development is currently involved with.
